# Our community plan

## Purpose of our community plan

This community plan has been prepared by the Serpentine and District Community Planning Group in partnership with the local community (including community groups, service providers, business and special interest groups).

The purpose of the Serpentine and District Community Plan is to:

- Provide opportunities for the community to be involved in shaping the future of the town and district
- Determine a vision for the community and a clear action plan to achieve that vision
- Identify the strengths and existing assets within the community
- Identify specific issues and challenges that may impact the community now or in the future
- Identify potential opportunities to enhance the community
- Create a sense of ownership of the plan by the community
- Develop a tool that can be used when applying for external funding.
- Provide Loddon Shire Council with an advocacy document identifying the community's priorities.

## History of community planning in Serpentine

In 2002 Loddon Shire Council activated the initial community planning program, encouraging communities to develop and submit their own community plans. The program was designed to create a sense of ownership and empower all community members to have input into developing a long-term vision and a set of strategic actions that will enable them to achieve that vision. The community plans were also intended to be an important tool for Council to use when preparing its own strategic plans.

The process of developing the first community plan for Serpentine was coordinated by local Serpentine residents and published in 2002. Then in 2021 the Serpentine and District Community Planning Group was reformed to develop a revised plan

## Our achievements since the first community plan was developed

Since 2002 many projects have been followed through to completion, including but not limited to:

- Redevelopment of the Janiember Park Recreation Reserve Hall and football and netball facilities
- Pondage Redevelopment – creating Pon Bon Reserve. This is now an area of native bushland offering walk trails.
- School Bus stop - established off the main highway to make it much safer for children to board and exit the bus from P-12 East Loddon College
- Improvements at Tom Rudkins Reserve and footpaths around the town

## The process of developing and reviewing our new plan

Loddon Shire Council introduced a new Community Planning Framework in November 2019.

This framework provided a guide to Community planning groups in regard to:

- Governance of Community planning groups.
- Community plan document format and content
- Levels of community engagement required to appropriately inform the development of the Community plan.

The development of the latest iteration of the community plan has been undertaken by a group of volunteers that represents a wide cross section of the local community, including:

- Community and sporting groups
- Young families and residents
- Businesses and farmers
- Seniors, including retirees and elderly residents

Initially a review of the content and format of the plan was undertaken by the Serpentine and District Community Planning Group to ensure that the plan was suitably presented and that it included relevant data as required by the framework.

A critical component of a community plan is the demonstration that a broad community consultation and engagement process was undertaken to help identify key direction areas and priority actions. The Serpentine and District Community Planning Group developed a consultation and engagement plan to ensure that this process undertaken was inclusive of the whole community.

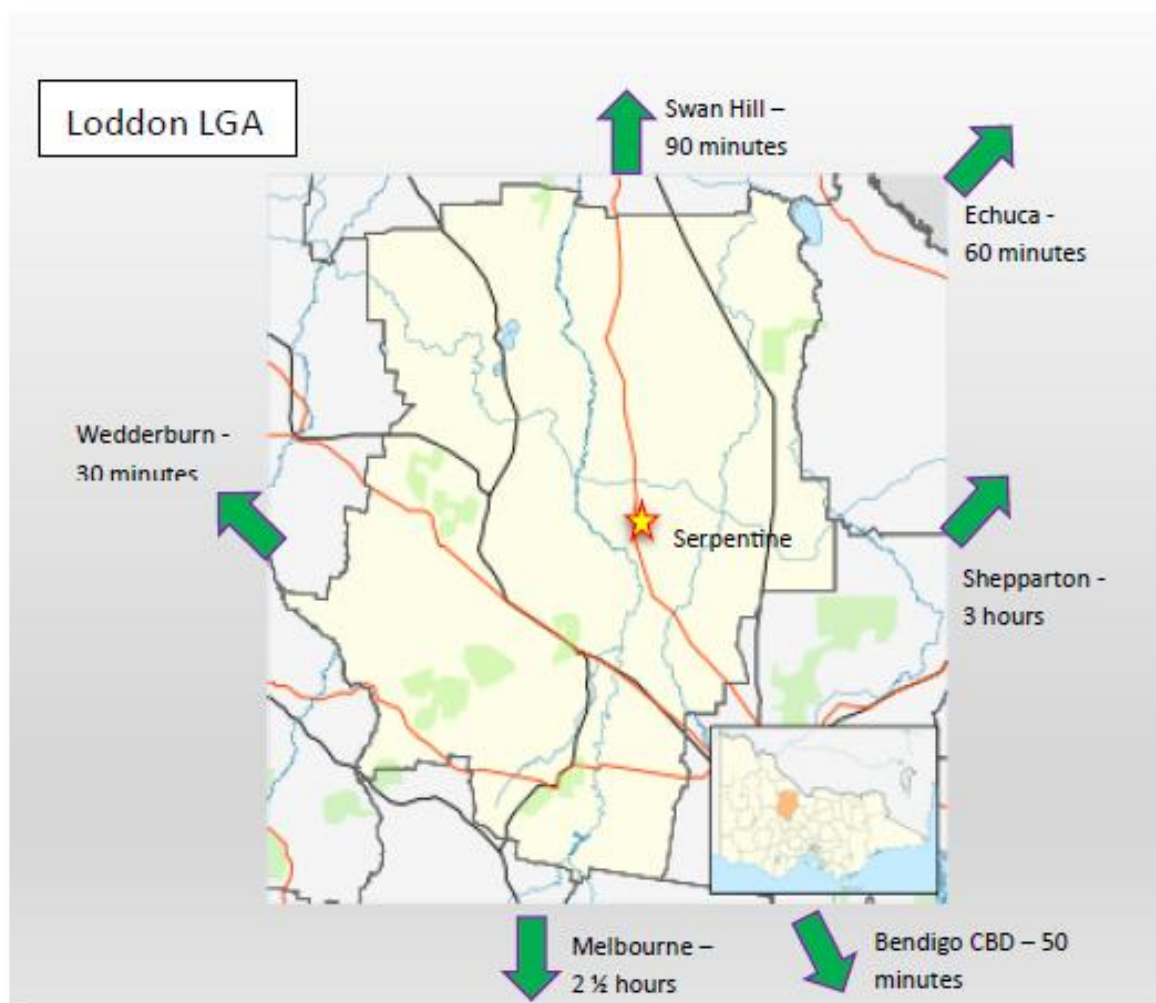
Part way through the implementation of the new plan, the Committee engaged Communityvibe and Iaimiga design studio to further review community priorities, edit the community plan and prepare designs for some of our priority projects.

The Serpentine and District Community Plan will be reviewed by the Serpentine and District Community Planning Group on a regular basis to ensure relevancy and status of identified actions and priority areas.

## Our town and district

Serpentine is the geographical centre of the Loddon Shire and has a township and surrounding district consisting of 222 people (ABS census 2021). The surrounding farming population is amongst the most innovative, successful farmers in the state. Farming enterprises include dry land and irrigated cropping such as cereal growing and lucerne pastures, beef production, prime lambs and wool production. There is also a vineyard, an olive grove, Farm Pride Egg farm and a large piggery enterprise nearby at Bears Lagoon, all providing employment in the district.

There has been increased productivity in the farming sector as a result of large investment in modern water efficient irrigation systems. Also, the addition of livestock farmers value adding with expansion of on farm beef and lamb grain finishing systems. The town is slowly growing and is expected to continue with the growth of Marong and Bridgewater flowing into Serpentine.



The township has strong and active sporting groups including tennis, football, netball and lawn bowls. Located only 50 kilometres from Bendigo, the area has access to superior educational facilities, job opportunities, sports and the arts. Serpentine has a playgroup, which is one of the oldest playgroups in Victoria and a Toy and Book Library, which also supports surrounding townships such as Calivil and Dingee. As Serpentine is located at the junction of the Loddon Valley Highway, Bridgewater Road and the Serpentine-Echuca Road, we live with a high volume of through-traffic, both day and night.

## Our assets

Our biggest assets are our people. They volunteer for our many groups and organisations; run and work in local businesses, farms and organisations; support events and activities; care for one another; are involved in learning; and proudly represent our community in many ways.

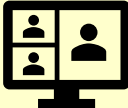

# Strategic Context

Twenty-eight local strategies and plans have been reviewed to identify their potential impact on Serpentine in the future. These plans, and their relevant aspects are as follows:

**1. Janiember Park (Serpentine Recreation Reserve) Master Plan 2009-2019**

Key directions of this Master Plan include:

- Increase and expand use of Memorial Hall (new change and social rooms have since been developed)
- Encourage informal recreation, e.g. paths in and around the recreation reserve and linking to new and existing tracks about the town; as well as informal family-oriented recreation opportunities
- Update and maintain existing infrastructure, e.g. new multi-use surface on netball courts, resurface oval, install new sprinkler system, install drought resistant turf on the oval, maintain synthetic cricket pitch; junior playground; picnic seating; BBQ; storage for playgroup; improve oval lighting; access quality and sustainable water
- Improved landscaping, taking into consideration drought tolerant low maintenance plants; the eradication of Bindii; formalised entrance; traffic calming measures
- Improved governance of the recreation reserve.

**2. Loddon Shire Access and Inclusion Plan 2018-2022**

This plan noted that the Serpentine public toilets have been upgraded to be universally accessible.

**3. Loddon Shire Activating Open Spaces Strategy 2019-2024**

This plan identified the need to upgrade the track condition and wayfinding on the Pon Bon Trail in Serpentine.

**4. Loddon Shire Annual Plan 2021-2025**

This plan noted the need to source funding to deliver flood mitigation works in Serpentine in 2022/23.

**5. Loddon Shire Building Asset Management Plan 2022**

This plan noted that both the Public Toilet at Rudkins Reserve and the Serpentine Shire Office are both Council controlled assets on Crown Land and that they require a review of the building control status.

**6. Loddon Shire Council Plan / Community Vision 2021-2025**

This plan noted the need to source funding to deliver flood mitigation works in Serpentine.

**7. Loddon Shire Environmental Sustainability Strategy Action Plan 2013 – 2018**

This plan identified as a high priority the need to seek external funding for the completion of a Township flood protection study in Serpentine, along with associated construction of levee banks or flood mitigation improvements.

**8. Loddon Aboriginal Community Partnership Plan 2019-2022**

This plan notes that Loddon Shire has been working with Dja Dja Wurrung to develop the canoe trail and promotional materials on the Loddon River and Serpentine Creek. It also recommends that the Aboriginal flag be flown at the Serpentine Council Office for the duration of National Reconciliation Week and NAIDOC Week.

**9. Loddon Shire Municipal Emergency Management Plan 2020**

This plan noted that Serpentine was inundated with flood water during the 2011 floods. It also notes that the Serpentine Council Office is listed as a secondary Municipal Operations Centre (after the Wedderburn office).

**10. Loddon Shire Neighbourhood Safer Places Plan 2023**

This plan notes that Serpentine Recreation Reserve (a portion of the oval – southeast corner) was designated as a Neighbourhood Safer Place (NSP) in 2012. It states that The Serpentine Recreation Reserve Committee of Management has been granted consent for the area to be used and has agreed to maintain the area as per CFA maintenance requirements. Council maintains all signage relating to the NSP.

**11. Loddon Shire Recreation Open Space and Aquatic Strategy 2024**

This strategy recommends maintaining the Serpentine Recreation Reserve; maintaining TJ Rudkins Reserve; maintaining Serpentine canoe trail; considering opportunities to enhance shared facility use between bowls and tennis as a short-term priority; and reviewing the bowls playing surface and lighting options as an aspirational priority. It notes that the lighting at the football oval and netball courts has been beneficial for players at Serpentine Recreation Reserve.

**12. Loddon Shire Recreational Leisure and Community Facilities Asset Management Plan 2022**

This plan notes that the bowls and tennis facilities in Serpentine are on land owned by Council and managed through a management agreement with user groups.

**13. Loddon Shire Road Asset Management Plan 2021-2025**

This plan noted that the width of various sections of the Echuca Serpentine Rd (i.e. Logan Kingower Rd and Sebastian Rd) are narrower than that prescribed in the Infrastructure Design Manual (IDM) for indicative maximum traffic volumes. It states that the roads above are anecdotally under capacity and that they need to be assessed against traffic volumes and referred to the rolling program for consideration and prioritisation as upgrade capital works (i.e. widening).

**14. Loddon Shire Road Management Plan 2025**

This plan lists the Bridgewater-Serpentine Road as a main road managed by the Department of Transport and Planning.

**15. Loddon Shire Rural Zones Review 2012**

This plan notes that “there is a high risk of agricultural land being lost to lifestyle development along the Loddon River between Serpentine and Eddington. This area is within half an hour of Bendigo and very attractive due to the river. It is also some of the best quality agricultural land in the area, with a number of very significant agricultural businesses including viticulture, horticulture and dairy. Non-agricultural land use in this area would pose a significant threat to these businesses, and significant commitment will be required to ensure housing is restricted to that essential to enhancing agricultural activity.”

**16. Loddon Shire Settlement Strategy 2019-2034**

This strategy notes that in 2019 there were 22 vacant land parcels in Serpentine covering an area of 150 hectares. This equates to 40 years of housing supply. Potential areas for growth include east of the highway in line with the recreation reserve and west of the intersection between Bridgewater-Serpentine Road and the highway. However, the strategy notes that the extent of the urban area in some towns (e.g. Serpentine) should be reviewed due to flood risk. It notes that reticulated treated water is available, but no sewer.

**17. Loddon Shire Social Infrastructure Strategy 2024**

This strategy identified the key social infrastructure assets of Serpentine and those that are within a 15- and 30-minute drive.

**18. Loddon Shire Economic Development Strategy 2025-2029**

This strategy lists several relevant Council priorities:

- Prepare a 'business support package' proposal to Council with modest financial support for businesses needing investment incentives (involving a possible mix of rate relief, infrastructure provision or support, and/or small capital works contributions).
- Contribute to development and delivery of Local Community Plans place making activities to support business development and viability.
- Identify priority services, infrastructure and development in southern areas of Loddon required to service the potential growth in the area due to Bendigo Regional Employment
- Support the implementation of township structure plans and/or relevant urban design frameworks through business case development that attracts funding support for high quality urban design and streetscape improvement works.
- Audit and improve township and way finding signage to showcase attractions and retail precincts in key settlements to boost visitor experience and place identity.
- Advocate for renewable energy projects and infrastructure that will enable Loddon to leverage opportunities associated with its natural resource endowment, particularly solar.

Information obtained from the community engagement activities held during January 2024 was used to identify key projects for the Serpentine and District community. A community plan was subsequently produced.

The community plan was reviewed by external consultants in late 2025 to assess priorities and to undertake further planning of initiatives identified in the first iteration of the plan. Once a revised plan was produced, an additional engagement session was held with the Serpentine Community Planning Committee by external consultants to retest the priority projects identified. Following this workshop, the community plan was amended accordingly.

## Vision, objectives and actions

The vision, objectives and actions selected have been identified by members of our community through consultation.

### Vision

The vision describes our ideal community and what we are aiming to achieve.

**Serpentine and District is a vibrant, active, inclusive and sustainable rural community that contributes to a prosperous and progressive Shire.**

## Actions

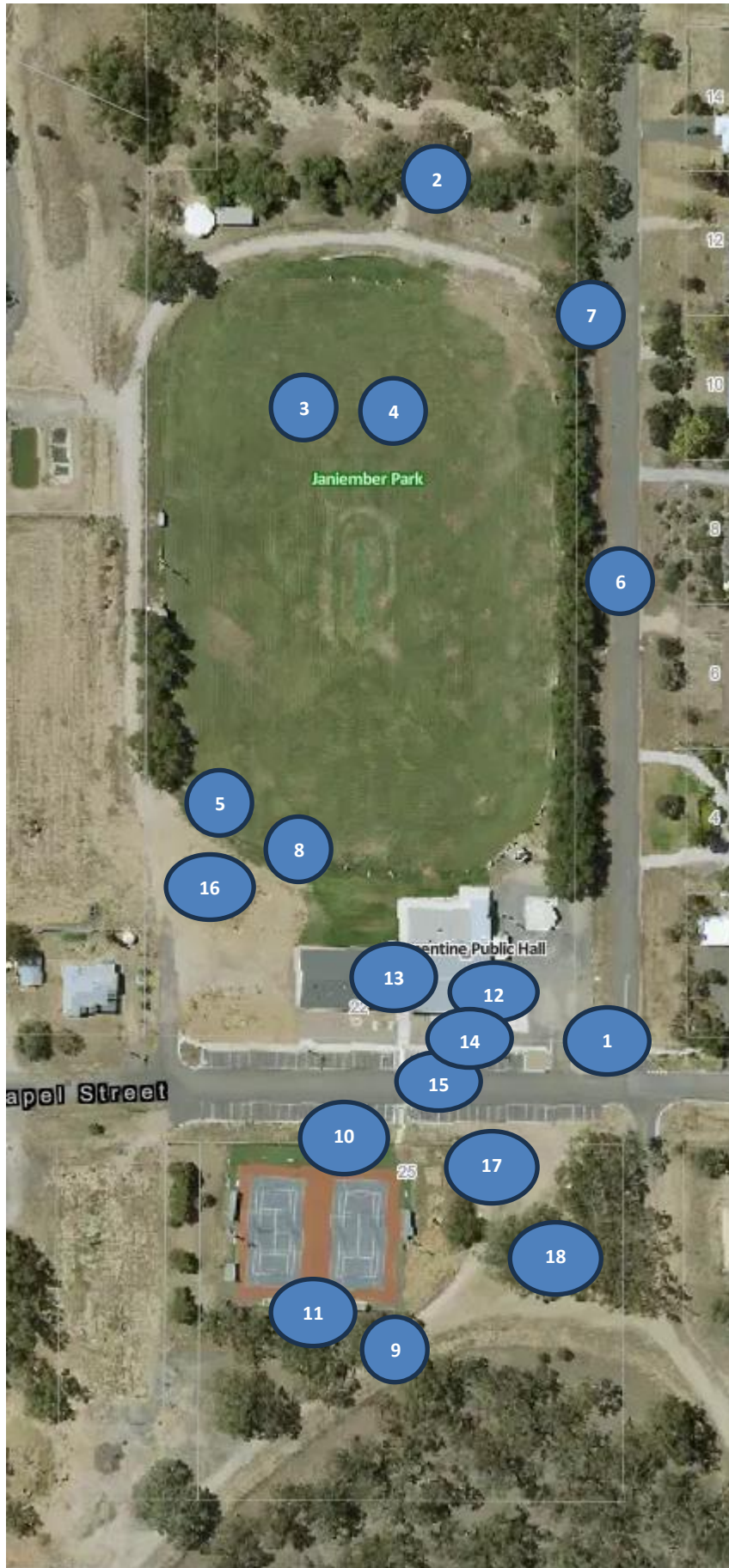

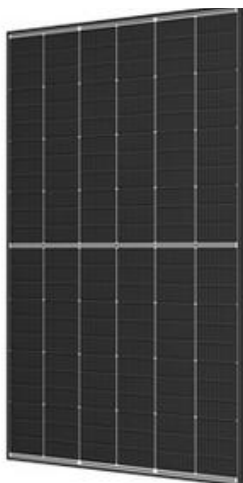

# Monitoring and reviewing our plan

Our plan will be monitored and reviewed regularly.

## **Monthly monitoring**

Our community plan will feature on the agenda of the Serpentine and District Community Planning Group each month. Committee members responsible for certain actions will be asked to provide updates on projects.

## **Annual review**

A desk top review will be undertaken with the Serpentine and District Community Planning Group annually. This process will include:

- Confirmation that priorities are still valid and that identification of any emerging issues exist that may change current priorities.
- Documentation of achievements of the past year.
- Update of plan to reflect any changes, e.g. Census/ABS data changes.

## **Mid- term review (4-5 years)**

At the mid-point of the plan, a desk top review will be undertaken to assess existing priorities and to identify any new and emerging issues. This will be undertaken by:

- A detailed discussion with the Serpentine and District Community Planning Group
- Community consultation to test the priorities and content in the plan. This can be as comprehensive as deemed appropriate by the committee and may include a general community survey and a review of any emerging issues.
- A review of community demographics based on latest Census/ABS data.

## **Full term: (10 years)**

A full review of the Community Plan will be undertaken when it reaches its full term (10 years). This full review will assess which actions were completed and which ones were not (and why); and the rationale for new projects being added and / or some projects being dropped off the action list. It is anticipated that funding will be provided by Loddon Shire Council at this point to enable the community to undertake a new community plan.
